

Summary and Recommendation

Staff recommends the City Council appoint two members to represent the City of Oakley on the East Contra Costa Fire Protection District Board.

Background and Analysis

The ECCFPD was established in 2002 with the consolidation of the Bethel Island, East Diablo and Oakley-Knightsen Fire Protection Districts. The ECCFPD serves the cities of Oakley and Brentwood, as well as the unincorporated areas of East County, including Bethel Island, Byron, Discovery Bay and Knightsen.

Two seats on the Board will be available this year. One seat is to fill a vacancy commencing office on September 1, 2014. The remainder of the term for this vacancy is until October 1, 2014. The City Council may decide to extend the term for two additional years or re-appoint the person who fills the vacancy to another two-year term at the expiration of the current term. The second seat will commence October 1, 2014 and will be for a two-year term. The appointees serve at the will and pleasure of the City Council.

Staff sought applicants to fill the position by publishing information regarding the vacancy on the City website and in the local newspaper. The deadline to apply was August 5, 2014. Staff received four applications which are attached for the City Council's review. The applicants have been notified that they should attend the City Council meeting as the City Council may desire to interview the applicants.

Conclusion

Staff recommends that the City Council adopt the resolution to appoint two members to the East Contra Costa Fire Protection District Board.

Background Information

The East Contra Costa Fire Protection District (ECCFPD) was established in 2002 with the consolidation of the Bethel Island, East Diablo and Oakley-Knightsen Fire Protection Districts. The District serves the cities of Oakley and Brentwood, as well as the unincorporated areas of east County, including Bethel Island, Byron, Discovery Bay and Knightsen. Pursuant to the Fire Protection District Law of 1987, the District operates as an independent public agency and the Contra Costa County Board of Supervisors initially served as the District's governing board.

In late 2009, the cities of Oakley and Brentwood, the County and the ECCFPD consented to local governance of the District. The newly-formed Board of Directors includes nine members: four from Brentwood, three from Oakley and two from the unincorporated County area, each residing within the District. The County solicited applications and appointed members of the general public for its Board seats; however, the two cities appointed Councilmembers. The Oakley City Council has now voted to appoint members of the general public (Oakley residents) to the Board seats, starting with two of the seats this fall and the remaining seat next spring. The first two seats will be appointed to 2-year terms and the remaining seat for a one-year term. The appointees serve at the will and pleasure of the City Council.

The ECCFPD Board currently meets the first Monday of every month in the evening. There is no compensation provided for Board Members.

It is a great honor to have an opportunity to serve my community which I have lived with my family since 1989. Since purchasing my first home on Locke Court, in 1989, I remember how Oakley languished as an unincorporated community under the control and guidance of the County Board of Supervisors. Those early years unfortunately, were not the best times for Oakley, as it was at a disadvantage due to its physical distance and limited influence with the County Board of Supervisors for services and adequate planning.

Fortunately I had the pleasure to witness Oakley's birth as a new incorporated city under the diligent guidance of its founding members and subsequent City Councils. It is a community that always makes the best of what resources it has in comparison to many other nearby communities. Due to its excellent leadership, Oakley has not experienced the negative impacts of growth some of its neighbors have had to endure. This has occurred because of special individuals who have given so much to their community to help it develop in a manner its citizens can be proud of.

It is this history of service that I wish to honor by serving as a Board Member under the guidance of the Oakley City Council to address the many challenges facing the East Contra Costa County Fire Protection District. I have a unique background that will allow me to work as a productive team member within the shared governance Board of the District to meet the unique challenges it is facing today. I am a 37 year veteran of the Fire Service initially beginning my firefighting career as a volunteer with the Alameda County OES Fire Department, I started my professional career as a Firefighter with a small two station Department (Dublin San Ramon Service District). I participated as a member of the organization several mergers, eventually becoming part of the now larger Alameda County Fire Department serving many incorporated communities and unincorporated similar to ECCCFPD. For the past 13 years I have served with the City of San Francisco Fire Department. I have served as a Firefighter Paramedic, Captain, Deputy Fire Marshal, Acting Fire Marshal and as an Arson Investigator. I have experienced the pains and challenges of shared governance through JPA's and Multi Service and Special District Agencies. I have experienced the challenges as well as benefits of agency mergers and dwindling resources and revenue streams requiring innovative and often difficult decisions to be made to provide the best service in the most difficult of times.

I am a full time Tenured Professor of Fire and EMS Technologies at Las Positas College in Livermore, and have been in the position since 1984. I have been a State of California certified Chief Officer since 1993. It is my position as an educator within the Fire Service that gives me a unique perspective and access to a networking environment within the Industry to identify and discover alternative models of service and unique revenue opportunities to enhance an agencies service profile and funding needs. I am saddened by the recent turn of events that have plagued the District and I believe that re-engaging the public and educating them with more defined facts of the impacts of the current limited service capabilities of the District and its real meaning to the community and future of the District are necessary.

9. What do you believe are the most pressing matters for the East Contra Costa County Fire Protection District.

The following are my lists of concerns for the District:

- Financial instability and continuing dwindling revenue streams with limited positive changes based on current taxation and distribution models for the future as well
- A model of service maximizing effective fire ground response for best outcomes based on limited resources.
- Utilizing a combination POC Service to augment fire ground operations while maintaining sensitivity to current employee labor groups
- Improving and seeking revenue streams that offer long term stability.
- Better public awareness as to current service model and its true impact to each member of the community and the increased risks associated with the diminished capacity of resources and personnel.
- Maintaining compliance with NFPA Standards of Service and Cal OSHA Impacts.
- Addressing moral within the department and the premise that ECCCFPD is no longer a destination Fire Department and will continually have difficulties with retainment of experienced journey-man firefighters thus reducing even further its effectiveness on the Fire Ground.
- Re-evaluating alternative Agency Models (i.e, mergers now that ECCCFPD is a smaller organization)

These I believe are the most pressing issues, however additional issues are also important but many can be diminished by the positive changes to many of the issues stated above.

There seem to be many pressing issues to me, a person simultaneously a citizen directly affected by fire protection activities in East Contra Costa County and an observer outside of the ECCFPD who tries to interpret mostly second hand information and differing opinions from the populous of the area.
