#### **Background and Analysis**

The Public Financing Authority (PFA) is a joint powers agency which was formed several years ago for the limited purpose of issuing bonds. The PFA is required to meet annually on the second Tuesday of December.

The PFA wishes to establish more frequent regular meeting which will better coincide with the need to approve the issuance of bonds and other debt for financing improvements of the City.

**WHEREAS**, the Authority desires to change its regular meeting date held annually on the second Tuesday in December to the second Tuesday each month to be consistent with the regular meeting times of the Oakley City Council and Oakley City Council Acting as the Successor Agency to the Oakley Redevelopment Agency. The time of the meeting shall remain the same.

**NOW, THEREFORE BE IT RESOLVED** that the Oakley Public Financing Authority does hereby amend Section 1 of Resolution Nos. PFA 01-03, PFA 02-08 and PFA 01-09 to read as follows:

"1. Regular Meetings. The regular meetings of the Board shall hereafter be held on the second Tuesday of each month at the hour of 6:30 p.m."
