Resolution Confirming the Actual Costs for an Emergency Abatement (3563

Main Street/APN: 035-121-004)

Background and Analysis

In accordance with OMC 1.6.138, if in the opinion of the City Manager a nuisance constitutes an immediate threat to the public, then the City Manager may abate such nuisance. The nuisance in question was located at 3563 Main Street and consisted of a broken front door window pane with jagged edges. (Photograph Page 2) The nuisance was abated by contracting a glass company that removed the glass and boarded up the door. Replacement glass was ordered but an unidentified party replaced the glass before the Cityhired contractor could finish the scope of work.

Per OMC 1.6.142 – 1.6.150, the owner has been provided sufficient notice to appeal before the City Council on June 13th, 2017. At this time the Council shall receive and consider the report of costs (Exhibit A) and shall hear any objections of the owners of the property to be assessed the abatement costs. The Council may modify the report if deemed necessary or may continue the hearing to another time. If no objections have been made or the City Council has overruled those made, the City Council shall, by resolution, confirm the report of costs as submitted.

Once City Council confirms the costs, the City Manager may still receive payment in full of the abatement costs charged against the parcel of land and prior to the filing of such report with the County Tax Collector.

The purpose of the attached Resolution is to ensure the City's expenses for performing the emergency abatement are recovered through the placement of a special assessment on the

property tax rolls. Contra Costa County Tax Assessor requires all special assessments be confirmed by the City Council.

Fiscal Impact

Adoption of the Resolution will authorize the City to place a lien on the property and recover the actual costs of the emergency abatement via direct assessment on the 2017-2018 tax roll.

Recommendation

Council adopt the attached Resolution confirming the costs for the emergency abatement and directing a special assessment and lien upon such parcel.
