This summarized Residential Project List is updated as needed and includes recently completed (built out) projects, all projects that are approved and/or under construction, and all submitted, but unapproved projects. This list is for informational purposes only and is not an approved or adopted document. Please contact the Planning Division at (925) 625-7000 if you request official documents, need further assistance, or have additional questions. Below are definitions for the table headings:

Definitions for table headings:

- “Subdivision Tract Number” refers to the tentative map number that was issued to the project. Numbers in parentheses represent the tentative map’s final maps.
 - “Development Name” refers to the common name of the project and/or developer. For accuracy, it is best to use the subdivision tract number when calling to ask questions. Some developers will combine two or more tentative maps into one marketed project.
 - “Project Location” refers to address or general location of the project.
 - “Resolution Number” refers to the number of the adopted Resolution approving the subdivision. PC and CC stand for Planning Commission and City Council, respectively.
 - “Approved Lots/Units” refers to how many total lots were approved on the tentative map. Approved Lots may include lots that have been issued permits but not yet completed as of the date of this list. Some numbers may be adjusted to match any final map lot numbers.
 - “Permitted Lots/Units” refers to the number of lots or units (for multi-family) issued building permits. This does not indicate the structure is complete and occupied.
